Fees and Invoicing:

Standard tuition is charged at £35 per hour for in-school sessions made payable by the trust/institution/school.

If parents/carers are liable for invoicing we suggest our standard academy tuition of £5 per hour with a minimum student booking of 15 per session.

Within tuition fees we include any preparation time, liability insurance, equipment provisions and materials.

We politely request that lyric sheets for students; provided in advance by the session leader via email, are printed by the school prior to the commencement of the class.

Bespoke curriculum tuition is quoted on a project basis and should be arranged and agreed on prior to the proposed start date.

Terms & Conditions:

PAYMENT - Termly invoices will be provided to institutions receiving services from our PHOENIX SCHOOLS programme. Sessions must be paid for in full prior to commencement of the course as we work on a monthly payroll.

REFUNDS - Student refunds will not be given should they miss a session. Cancellations mid term will be considered for refund of remaining sessions in exceptional circumstances.

COURSE CANCELLATIONS - Courses/Clubs cancellations will be considered up to four weeks prior to the commencement of the proposed course/club.

Courses/Clubs booked by a school/trust/academy/institution/organisation have a termly commitment to the Phoenix Academy of Film and Theatre Arts as per this agreement and will accept financial liability for the proposed course should they deviate from the stipulated conditions. Failure to do so will result in legal action.

PROVISIONS - A space suitable for the specified activity should be provided for each session. Failure to do so will result in deviation from the curriculum. Refunds will not be issued should an inadequate space be provided. An example of a suitable space would be a dance studio, drama studio or hall.

COVER STAFF - Replacement/Cover staff will be provided should a session leader be unable to attend a session.
